Work hand delivered for jurying, and work accepted on-line must be delivered on Friday, 3/1, 1-5 PM and Saturday, 3/2, 1-5PM.

open from 2/3 to midnight on 2/22. Notifications of acceptance for on line entries will be sent on 2/24 after 6 PM.

WORKS ELIGIBLE: This is an open, ALL MEDIA juried competition on the theme of FLOWERS. Submitted pieces can be 2 or 3 dimensional and must be offered for sale during the exhibition. Maximum framed size is 44 inches in width including the frame. All 2-D work must be wired and ready for hanging and be under 30 pounds. Non -suitable pieces will be rejected. Work accepted on-line that is deemed non-suitable upon delivery at the PSC will not be displayed. All work must be original and not previously shown at PSC. **2-D work must be framed and wired for hanging.** Giclees of computer-generated art ONLY will be accepted. Size is limited to 40" in either direction including frame. All work must be for sale.

HAND DELIVERED ENTRY FEE: PSC and Plastic Club members: \$12.00 for one entry, \$20.00 for two; Non-members: \$15.00 for one entry, \$25.00 for two. Hand delivered entries are limited to two per entrant.

ON-LINE ENTRIES: PSC and Plastic Club members: \$25 for up to 5 entries; Non-members: \$25 for up to three. Fees are not refundable.

JUROR: Paul DuSold, noted Philadelphia Artist
Juror's results will be posted on line & mailed .
Please do not call for results.

AWARDS: Cash awards in each category.

RECEPTION: Artists and patrons are invited to attend the opening reception on Sunday, January 6th from 2-4 PM. Awards will be presented at 3

PM. Work cannot be picked up until after the end of the show.

SALES: With the exception of holidays, the Sketch Club will be open Mon., Wed., Fri., Sat. and Sun. from 1-5 PM. Sales commission 25%.

DELIVERY: Work accepted by Juror on line and work to be juried in person must be dropped off at the Sketch Club March 29th and 30th, 1-5 PM each day. To accomodate artists outside of Philadelphia, work may be delivered to sites identified on the reverse of the identification card by appointment only. Works stored at owner's risk.

PICK UP: All work must be picked up by 3/30. Work not removed on these days may be picked up by appointment only. Work stored at owners risk for a fee of \$2 per day.

LIABILITY: Work will be handled with care, but the PSC cannot be responsible for loss or damage.

AGREEMENT: Entering work in this show shall imply an agreement by the artist with all conditions set forth. Jurors shall have the sole and final decision regarding awards.

For each entry, fill out forms and certification card. **DO NOT FILL IN NUMBERS.** Attach form to upper right rear of painting. Bring your work, entry fee, file form and certification card on 3/1 and 3/2. **On-line entry instructions on reverse of this form.**

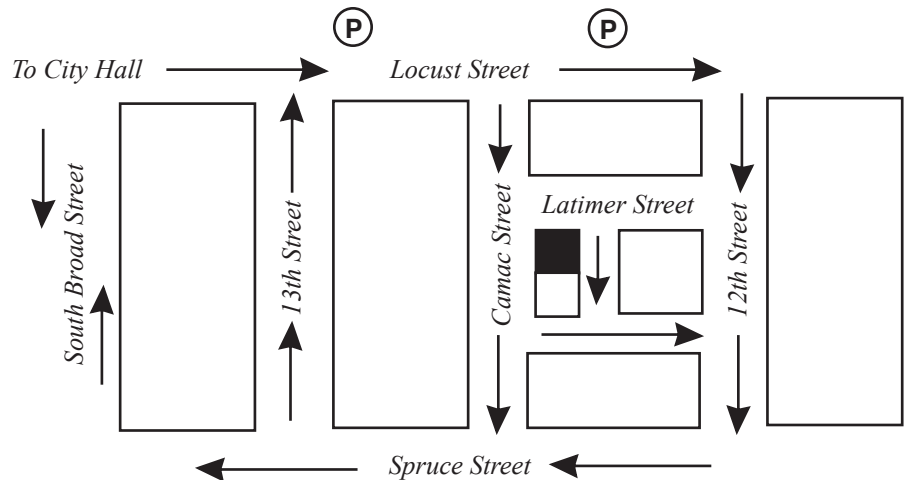
How to enter the exhibition on-line:

1. Visit www.sketchclub.slideroom.com anytime between 2/3/2013 and midnight 2/22/2013.
2. Create a log in and password. This password will need to be activated using the email message that will be sent to you directly after creating a log in. If you have entered on line before using slideroom, you do not have to create a new log in.
3. Click on "Art of the Flower 2013" program on the sketchclub.slideroom site and upload up to 3 (5 for PSC and Plastic Club members) images for \$25 (include description, price, and dimensions)
